- Outperformed Policy Index by 90 bps

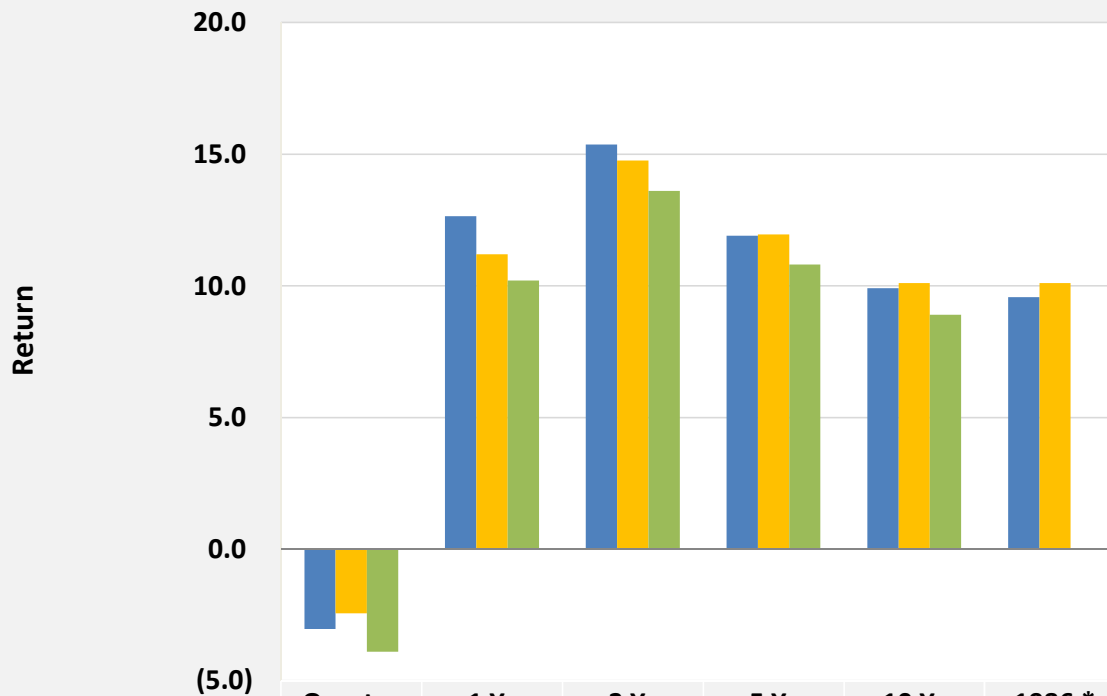

Endowment Total Return



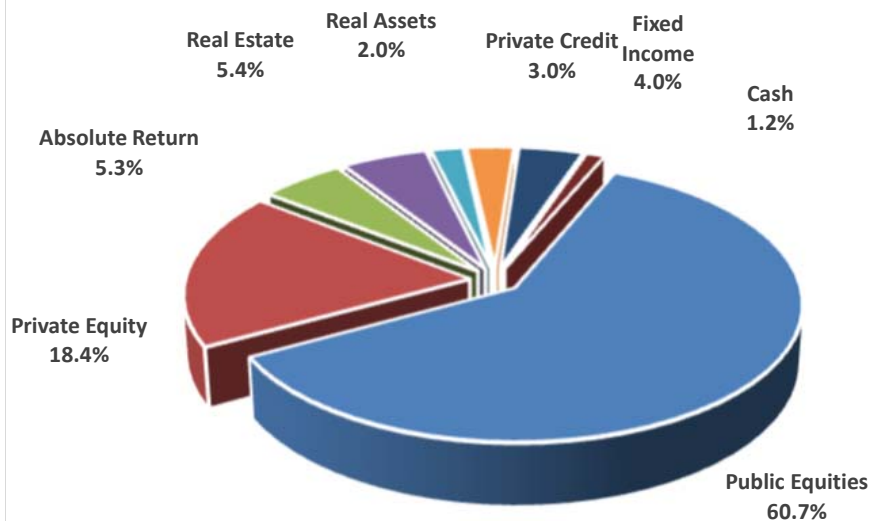

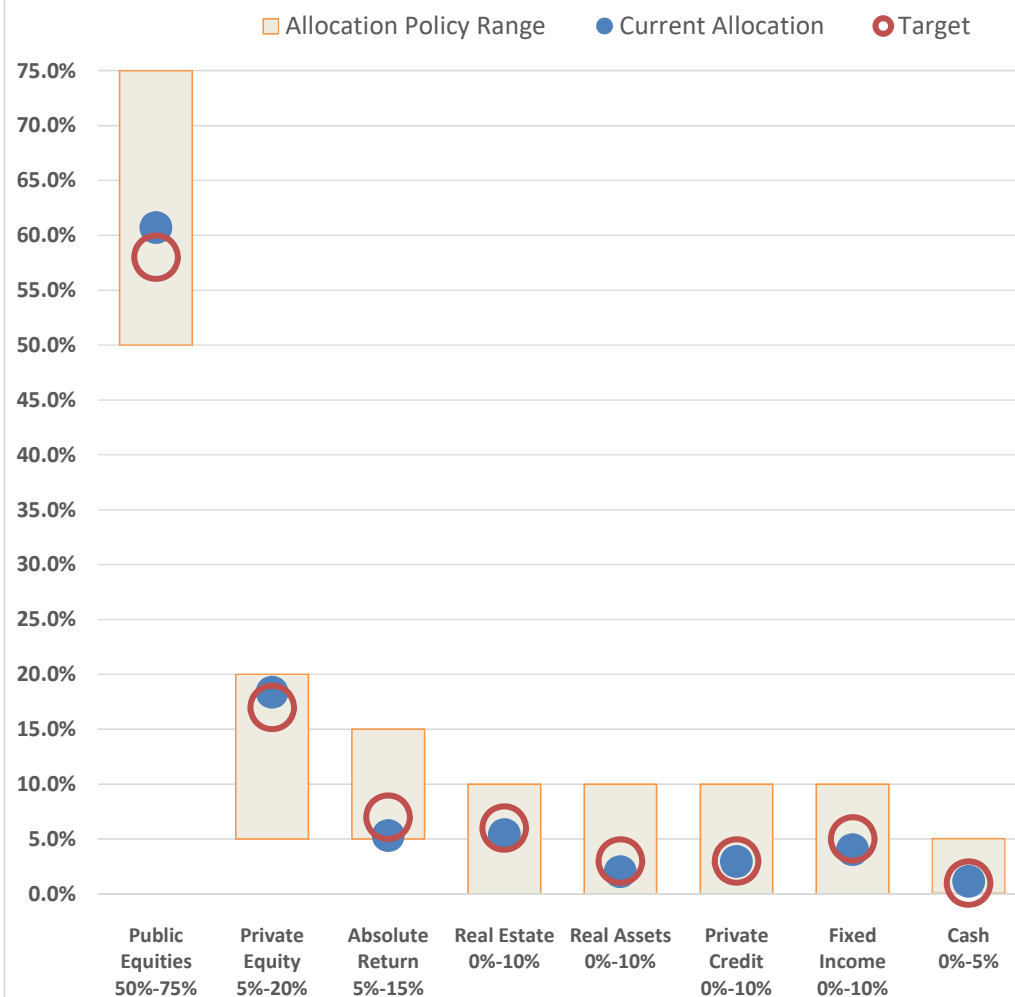

Asset Mix



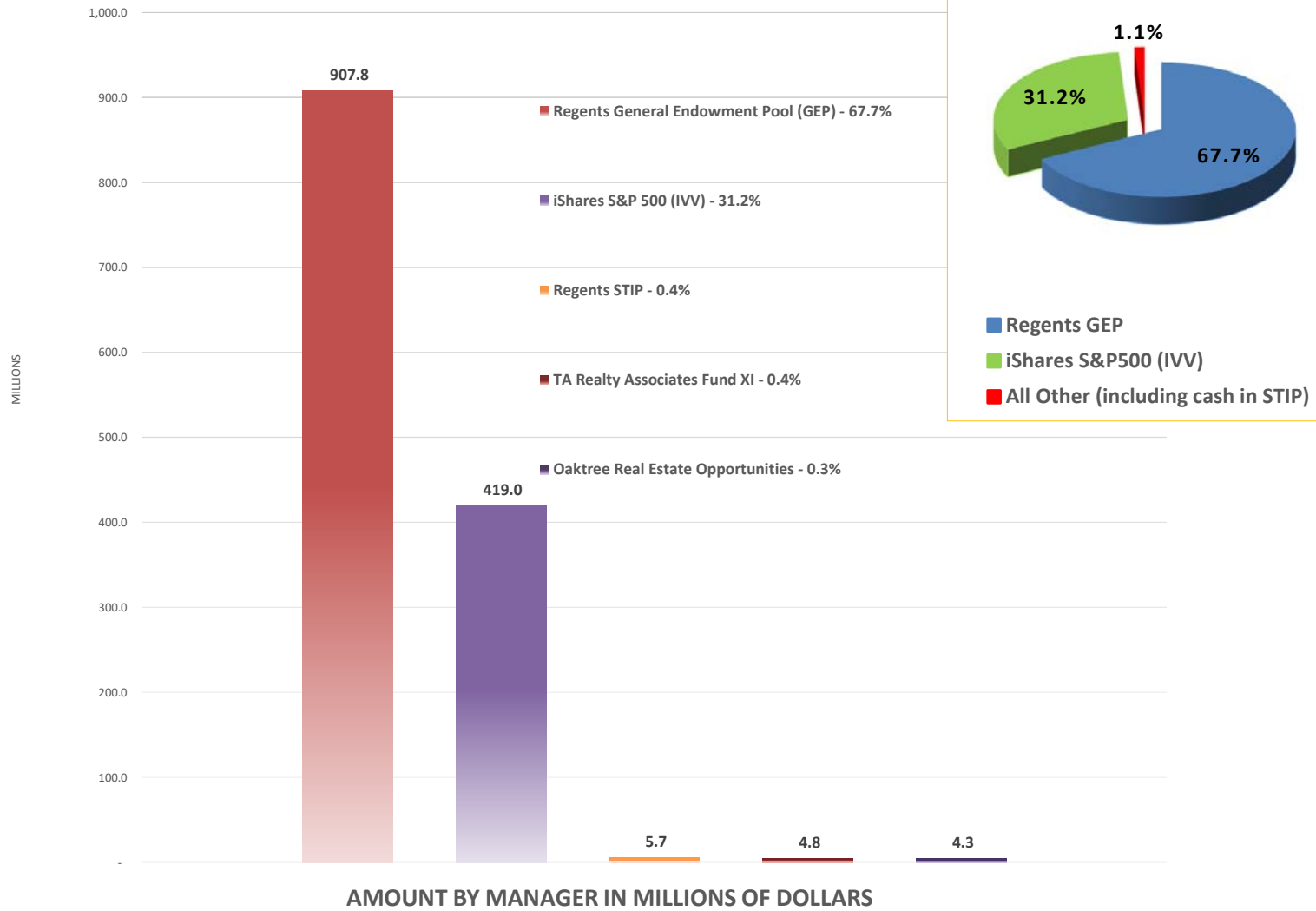
