- Matched Policy Index performance of 11.1

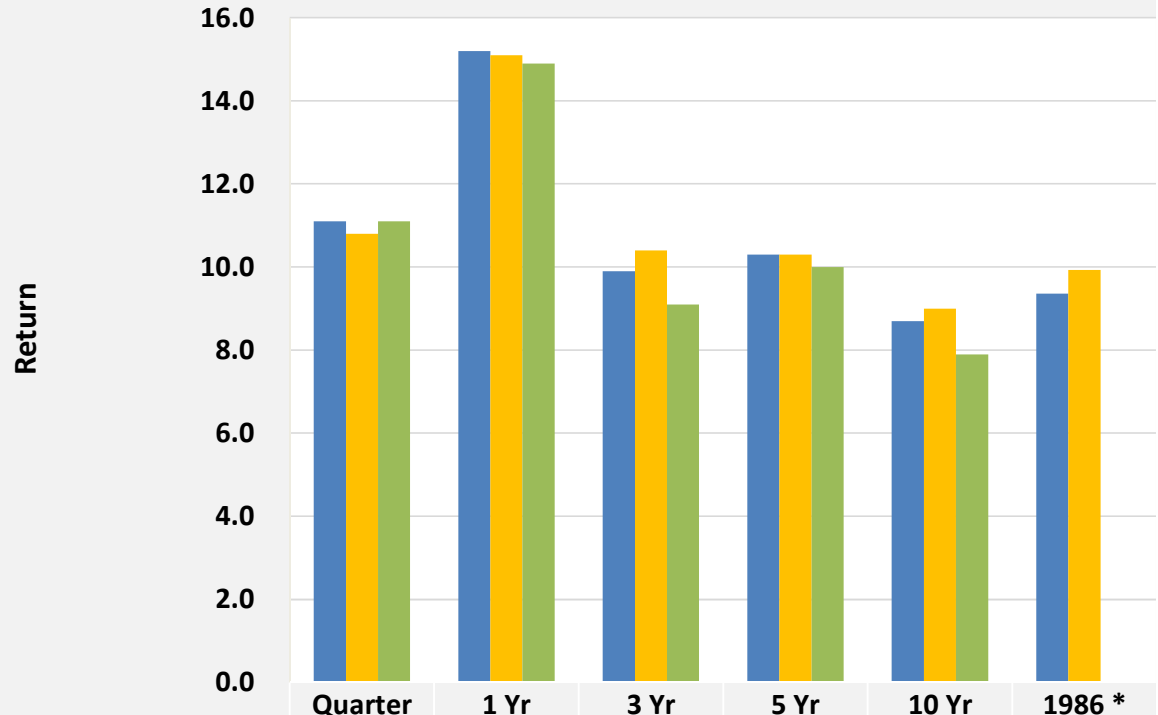
Asset Allocation

Endowment Total Return



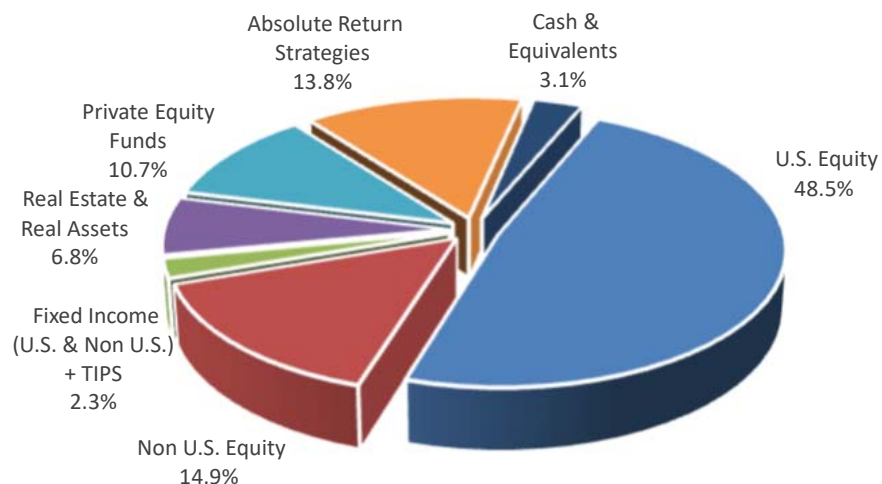

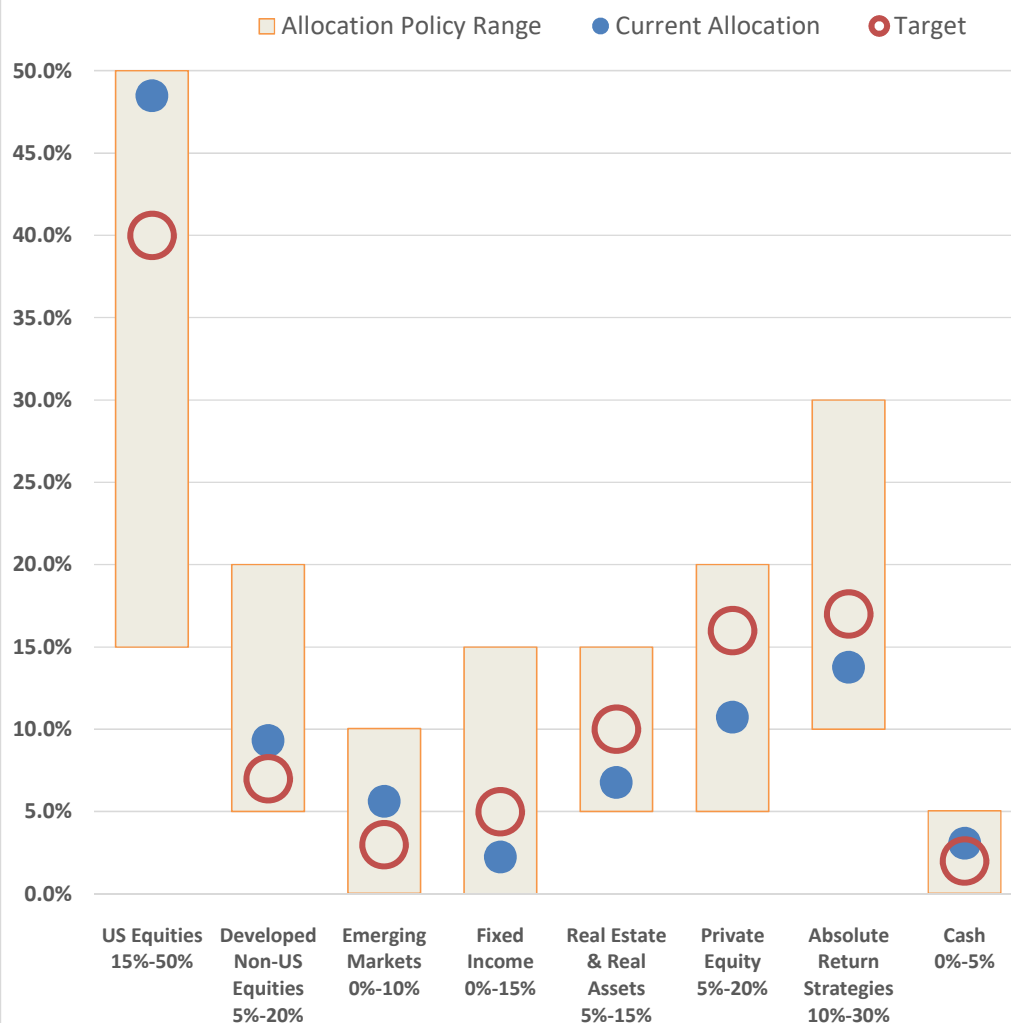

Asset Mix



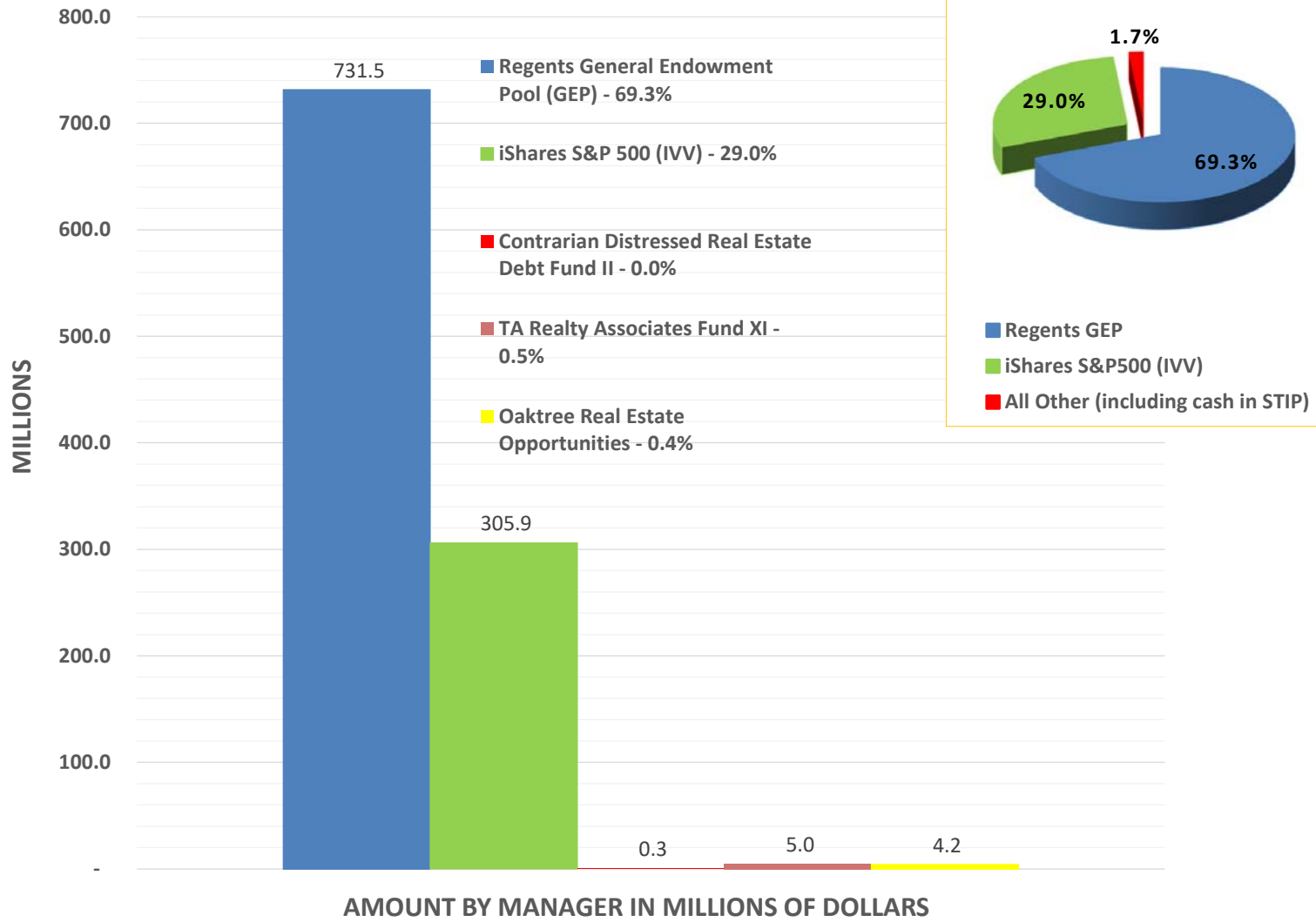
