- Outperformed Policy Index performance by 110 bps

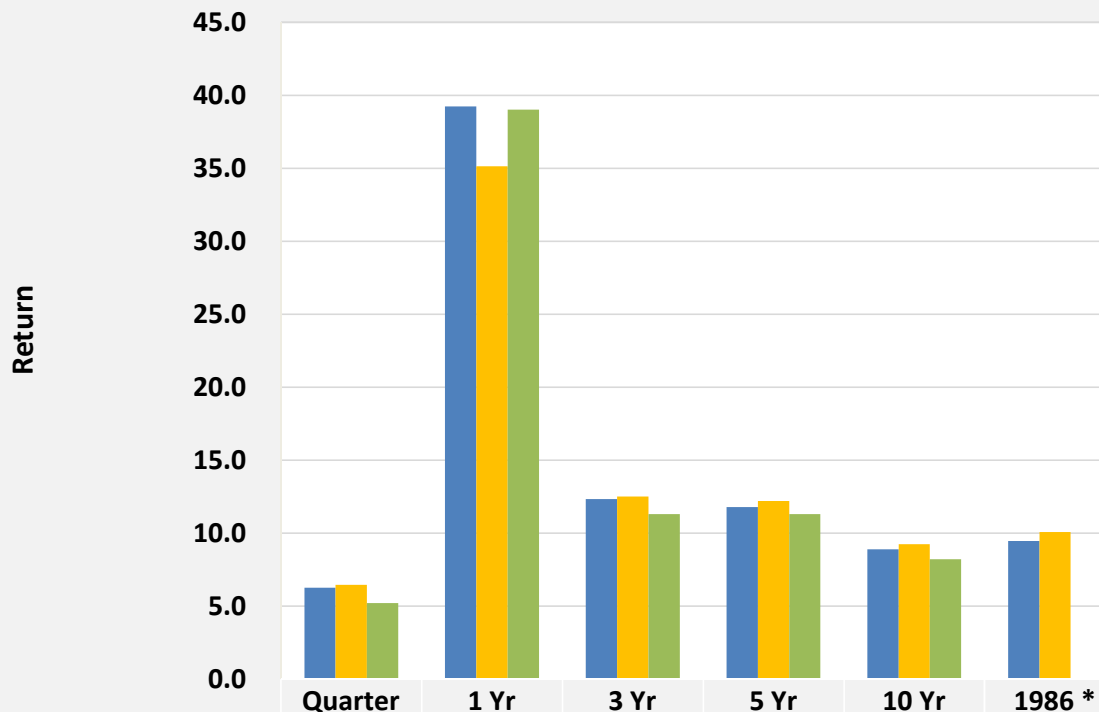
Asset Allocation

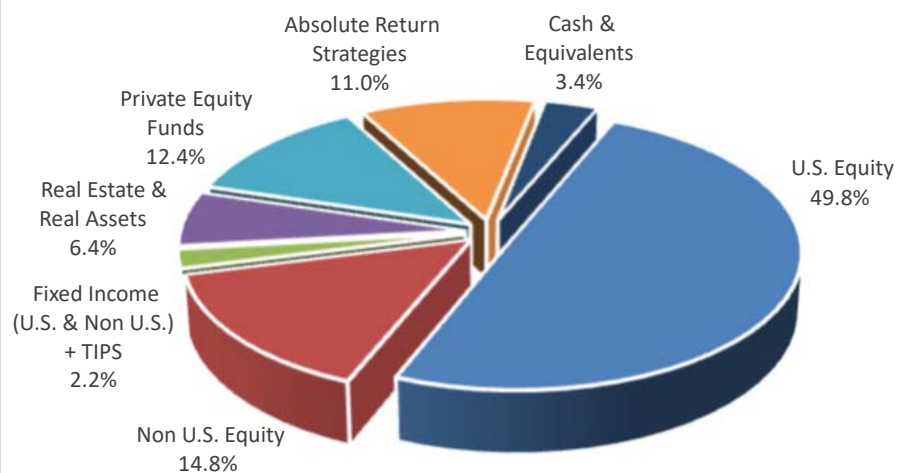

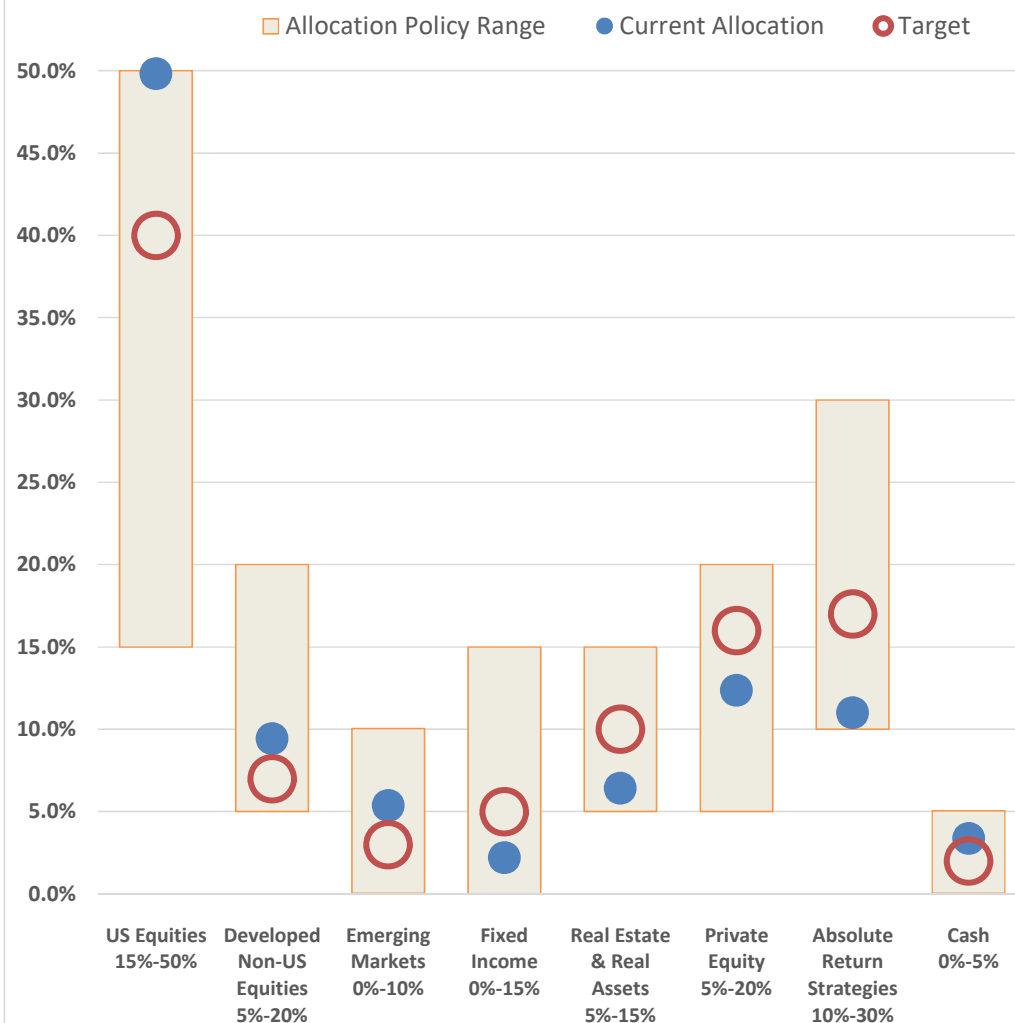

Asset Mix



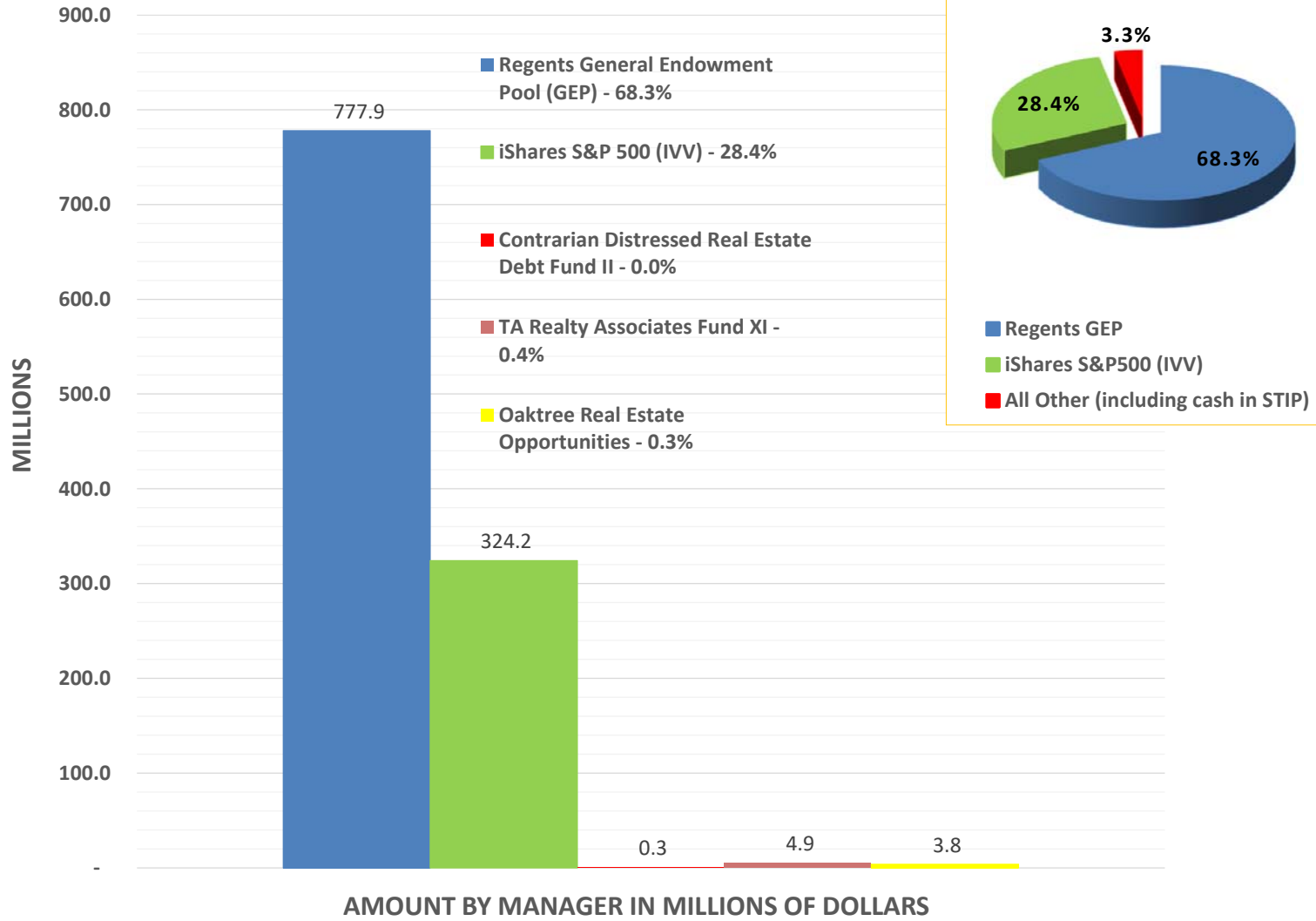
