Quarter at a Glance

Endowment Assets Under Management

- \$1,544.4MM (Main Endowment + Sanford IEC FFE) increase of \$89MM during quarter

Portfolio Performance

- Outperformed GEP by 167 bps
- Underperformed Policy Index by 78 bps

Asset Allocation

- Underweight Absolute Return **-4.3%** relative to long-term target of 7%
- Overweight Public Equities **+4.8%** relative to long-term target of 58%

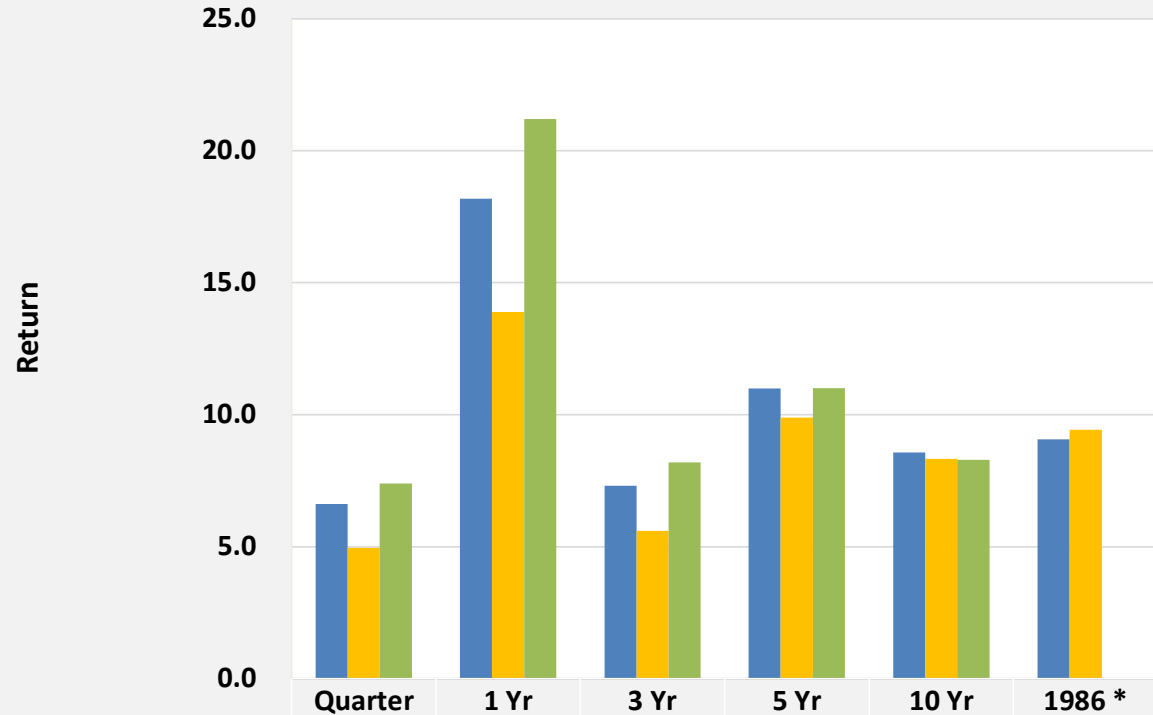

Endowment Total Return



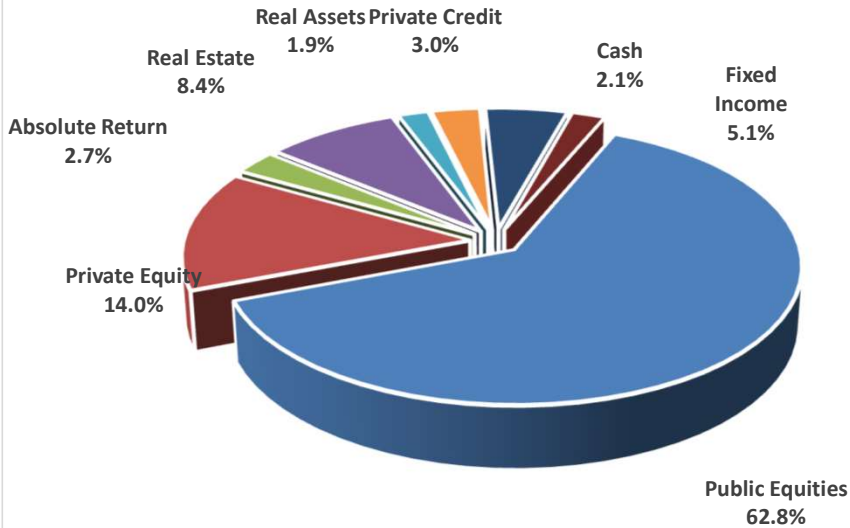

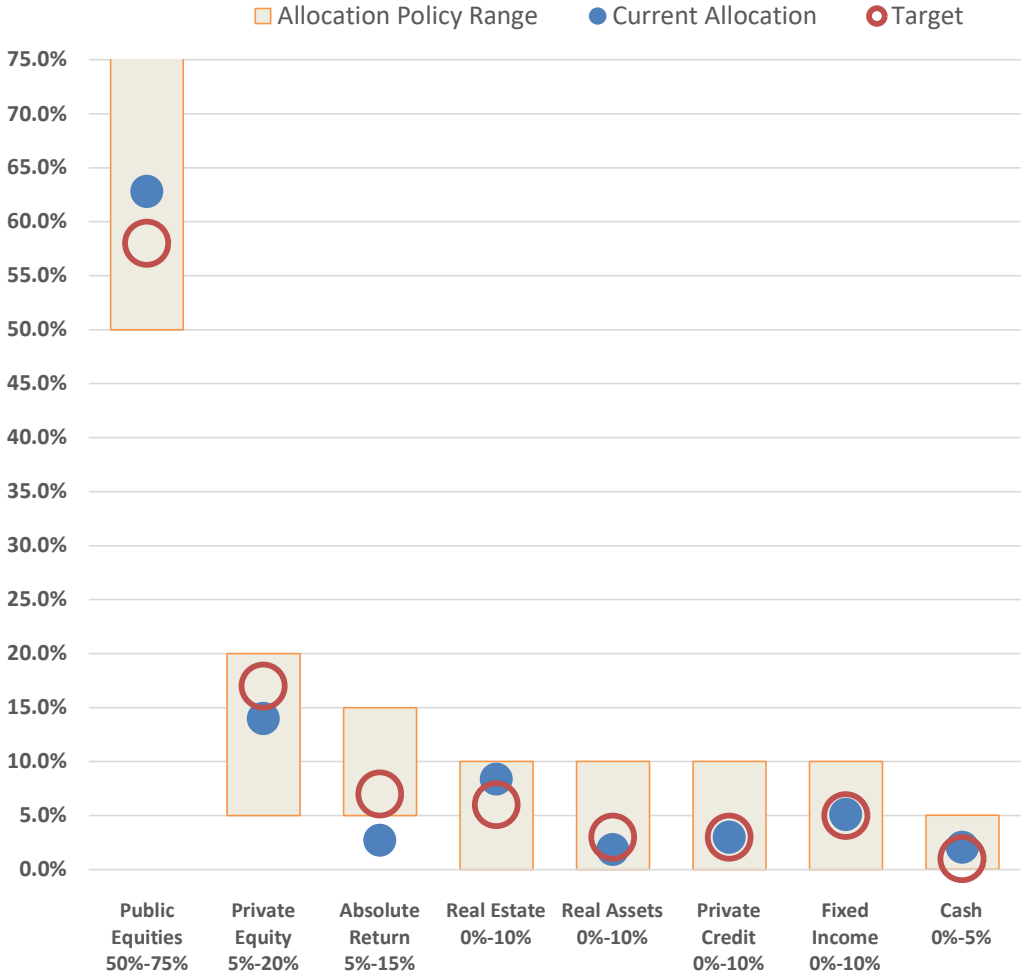

Asset Mix



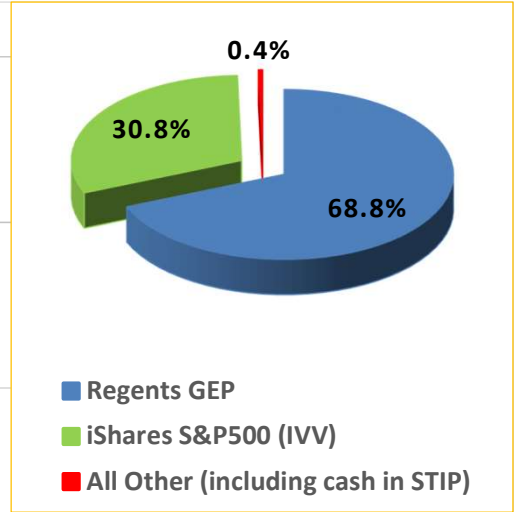
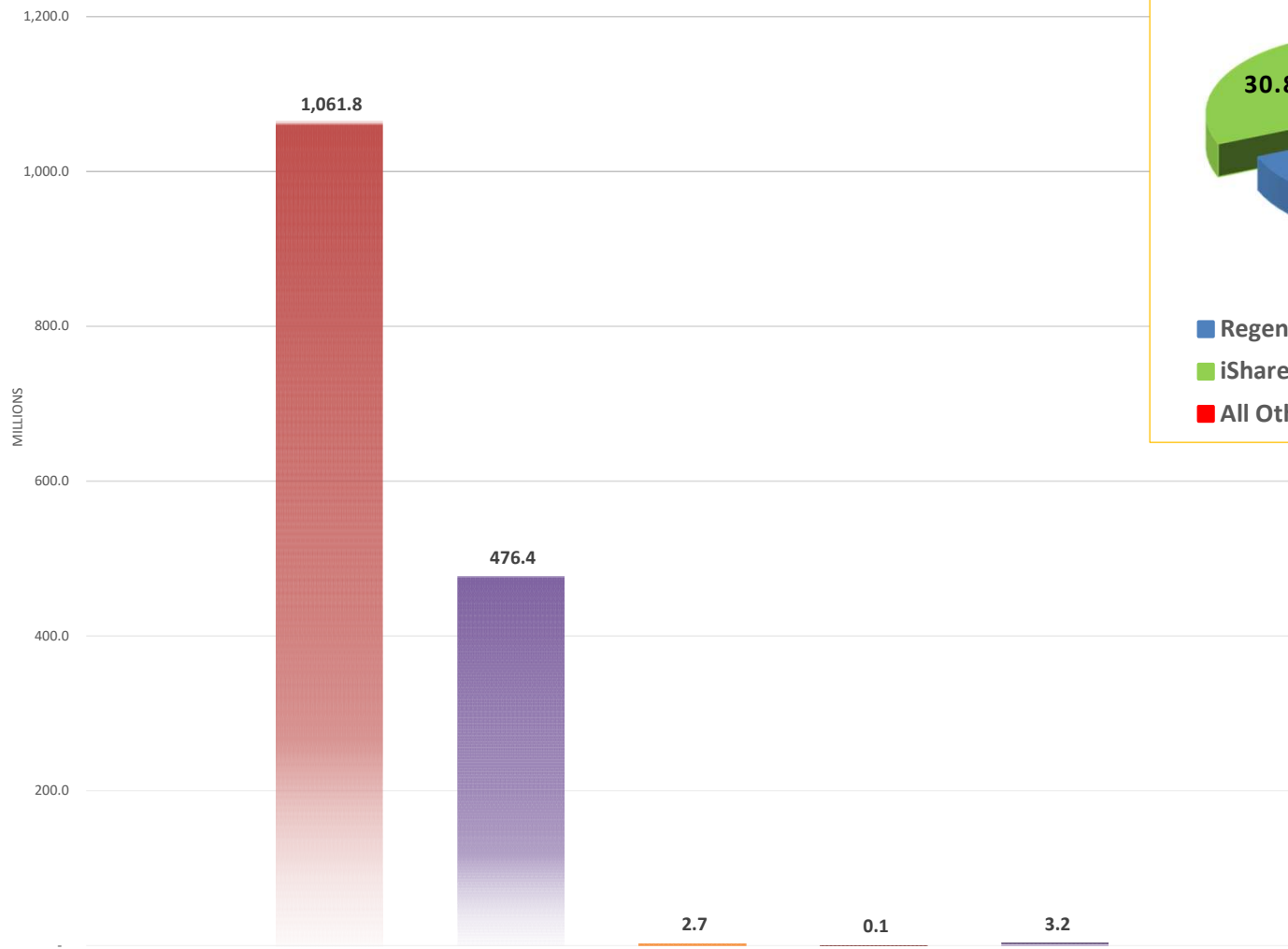
